This notice concerns the 2020 property tax rates for CITY OF RIO HONDO. This notice provides information about two tax rates. The no-new-revenue tax rate a rate would impose the same amount of taxes as last year if you compare properties taxed in both years. The voter-approval tax rate is the highest tax rate a rate would impose the same amount of taxes as last year if you compare properties taxed in both years. The voter-approval tax rate is the highest tax rate a taxing unit can adopt without holding an election. In each case, these rates are calculated by dividing the total amount of taxes by the current taxable value with adjustments as required by state law. ### ORDINANCE NO 2020-10

AN ORDINANCE LEVYING AD VALOREM TAXES FOR THE MAINTENANCE AND OPERATION OF THE MUNICIPAL GOVERNMENT OF THE CITY OF RIO HONDO, TEXAS, BEGINNING OCTOBER 1,2020 AND ENDING SEPTEMBER 30, 2021 DISTRIBUTING THE TAX LEVY AMONG THE VARIOUS FUNDS, AND PROVIDING FOR A LIENON REAL AND PERSOAL PROPERTY TO SECURE THE PAYMENT OF TAXES ASSESSED

BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY OF RIO HONDO, TEXAS.

Section 1. That there is hereby levied and there shall be collected for the maintenance and operation of the municipal government of the City of Rio Hondo, Texas for the 2020-21 Fiscal Year upon all property, real, personal and mixed, within the corporate limits of said City subject to taxation, a tax of \$0.826004 cents on each One Hundred Dollars (\$100) valuation on property.

# THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

Section 2. That there is hereby levied and there shall be collected for the City of Rio Hondo, Texas to provide for Interest and Sinking Funds for the 2020-21 Fiscal Year upon all property, real, personal property, within the corporate limits of said City subject to taxation, a tax of \$0.227640 cents on each One Hundred Dollars (\$100) valuation on property.

That the City Administrator shall ensure that the City's home page of its internet website shall include the following statement: "THE CITY OF RIO HONDO ADOPTED A TAX RATE THAT WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEARS TAX RATE."

Section 3. That all monies collected under this Ordinance for the specific items herein named, be and the same hereby appropriated and set apart for the specific purposes indicated in each item and the Assessor/Collector of Taxes, and the City Administrator shall keep these accounts so as to readily and distinctly show the amount collected, the amount expended and the amount on hand at any time belonging, to such funds. All receipts for the City not specifically apportioned are hereby made payable to the General fund.

Taxes levied under this Ordinance shall be due October 1, 2020 and if not paid on or before January 31, 2021 shall immediately become delinquent.

Section 4. All taxes shall become a lien upon the properly against which assessed, and the tax assessor and collector for the City of Rio Hondo is hereby authorized and empowered to enforce the collection of such taxes according to the Constitution and laws of the State of Texas and Ordinances of the City of Rio Hondo shall, by virtue of the tax rolls, fix and establish a lien by levying upon such property, whether real or personal, for the payment of said taxes, penalty and interest, and the interest and penalty collected from such delinquent taxes shall be appropriated to the General Fund of the City of Rio Hondo. All delinquent taxes shall bear interest from date of delinquency at the rate prescribed by state law.

Section 5. That this ordinance shall take effect and be in force on October 1, 2020.
